ORDERS BY THE GOVERNOR, MANIPUR
Imphal, the 15th April, 2017


No.21/4/2013 – DIT (Pt-I): In pursuance of Memo No. 10(36)/2015-EG-II(Vol-V) dated 25th March, 2017 from Ministry of Electronics and Information Technology, Government of India, the Governor of Manipur is pleased to direct all State Government Departments and Agencies under the Government of Manipur to refrain from any act of publishing personal identity or information i.e Aadhaar number and demographic details along with personal sensitive information such as bank details, in contravention of the Aadhaar Act, 2016 and Information Technology Act ,2000 and such content already published and still appearing publicly may be discontinued with immediate effect.

2. The act of publishing identity information i.e Aadhaar number along with demographic information such as name, date of birth, address etc. is in clear contravention of the provisions of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016, more specially Section 29(2), Section 29(3), and Section 29(4) and constitutes an offence under Section 37, 40 & 41, punishable with imprisonment upto 3 years.

3. Further, publishing of financial information including bank account details, being sensitive data, is also in contravention of provisions under the Information Technology Act, 2000 and the Rules framed thereunder, more specifically Rule 3 & Rule 6 of the Information Technology Rules, 2011 and constitutes an offence under Section 43 A of the Information Technology Act, 2000 and offending parties are liable to pay damage by way of compensation to the person affected.

4. All Departments and Agencies under the Government of Manipur are informed to submit a compliance report by 19th April, 2017 as per format at Annexure-I.
