Subject: Instructions regarding deduction of Agency Charges from the provision of works.

No.5/6/2006-FC: Instructions were issued vide the O.M. of even number dated 26.02.2007 regarding deduction of agency charge of 11.75% and deposit the *entire* amount in the Government Head of Account

The matter was subsequently reconsidered and revised instructions were issued vide O.M. of even number dated 13<sup>th</sup> July 2007 allowing the work agencies to retain a part of the agency charge and deposit the rest in the Government account

Considering the huge increase in flow of fund to the various Work Agencies of the Government over the years and the prevailing financial position of the State, it has been decided to revisit the rates of Agency charges to which some of the Work Agencies/ PSUs/ Autonomous bodies are entitled to from the provision of works

in partial modification of this Government's O.M of even number dated 13.07.2007, it has been decided to modify the agency charges to be deposited in the Government account in case of the following Work Agencies/ PSUs/ Autonomous bodies as per the details given below:
