**Invitation for Expression of Interest for
"Consultancy Services for the Construction of additional / alternate alignment to avoid sinking zone
between Mao & Maram (km 212.325 to km 235.80) on NH-39 in the State of Manipur"**

1. The Ministry of Road Transport & Highways is under finalization for seeking approval of the Cabinet Committee on infrastructure (CCI) for the above work under SARDP-NE phase 'A' (copy enclosed). The Ministry has decided, with the approval of the Hon'ble Ministry (RT&H), to take advance action for preparation of DPR pending approval of the proposal by CCI. The Ministry has therefore requested the State P.W.D. to make immediate necessary action for the preparation of the DPR for the said work.

Expression of Interest for undertaking relevant survey works – geotechnical survey, SSI, C.D. structures including Bridges, alignment survey, design of pavement etc are invited from the empanelled consultants in the relevant category with the MORT&H for preparation of detailed project report for "Construction of additional / alternate alignment to avoid sinking zone between Mao-Maram (km 212.325 to km 235.80) on NH-39 in the State of Manipur" in two cover system (Technical and Financial bid).

2. The Firms must submit the EOI in the prescribed format. The following shall be a part of the bids.
 - General & Overall experience.
 - Experience of working in similar geographical region.
 - Experience in the required area of expertise i.e. of performing works of similar nature in the context of the steep & mountainous terrain.
 - Annual turnover for the last five years.
3. EOI must be delivered to the office of the undersigned on or before 15:00 hours of 5th October, 2011 and will be opened on the same day at 15:30 hours in presence of the Consultants or their authorized representatives who wish to attend.
4. All the Consultants must submit their documents in hard bound copies otherwise their bids will be rejected. Spiral / Comb binding etc. are not acceptable.
5. The EOI documents and terms of Reference can be had from the office of the undersigned during office hour on payment of Rs. 5000/- in cash or DD drawn in favour of the Executive Engineer, National Highways Division No.-I, PWD, Manipur upto 3:30 pm of date 27th Sept., 2011. Firms who wish to obtain the documents through post shall have to pay an additional amount of Rs. 1000/-. The Department shall not be held responsible for any postal delay.
6. On the basis of the submissions, the firms shall be shortlisted and invited for submission of their bids for the consultancy, in accordance with Ministry's Guidelines on the use of Consultants. Selection of the consultant shall be done under QCPC (Quality CUM Performance Criteria) in accordance with the Ministry's Guidelines.
