Sub :- Payment of Dearness Allowance to the serving Manipur  
Judicial Service Officers -

**No.17/1/2010-FD(PIC)** : In continuation of this Government Office Memorandum of even number , dated 20/11/2017, the Governor of Manipur is pleased to enhance the Dearness Allowance payable to the serving Manipur Judicial Service Officers at the following rates :-

Date of effect	Rate of Dearness Allowance
01/01/2018	139% to 142% of Basic Pay
01/07/2018	142% to 148% of Basic Pay

2. The term 'pay' for the purpose of calculation of Dearness Allowance shall be the pay drawn in the prescribed scale of pay including stagnation increment(s) but shall not include any other type(s) of pay like special pay or personal pay etc.
3. The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of FR 9(21).
4. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.
