- 2. It shall be the responsibility of the Officer concerned to invariably intimate Link Officer or his Alternate Link officer in the absence of his link officer the details of his leave / tour / training etc, in writing before proceeding on such leave / tour / training etc. under intimation to the Chief Secretary, Government of Manipur.
- 3. It shall also be the responsibility of the officer to ensure fthat the personal staff attached to his Office attend office during his absence on leave / tour / training etc., and their services are made available to the link / alternate link officer.
- 4. In the absence of Commissioner / Pr. Secretary of <u>Home department</u>, files would be submitted by Special Secretary / Addl. Secretary / Joint Secretary / Deputy Secretary directly to the Chief Secretary.
- 4. In case, both the Link Officer and the Alternate Link Officer are away on leave / tour / training etc., the Officer concerned shall request DP to issue specific orders in each case.
