In exercise of the powers conferred by Clause (3) of Article 166 of the Constitution, the State Government hereby makes further amendment to the "Delegation of Financial Powers Rules, 1995" of the Government of Manipur namely:-

No. 64

Page 7 & 8 of the Delegation of Financial Power Rules, 1995 as incorporated in the Manual of Financial Procedures, 1995.

Rule 12(a), (b) & (c) read with Amendment No.44 issued under notification No.1/2/2001-FD(EXP) dated 21.08.2003 shall be substituted as follows:-

Rule 12. Sanction of Public Investment Board (PIB):-

- (a) No proposal involving any Project/Scheme other than those taken up under a Centrally Sponsored Scheme (CSS) or Central Plan Scheme (CPS) or any other 100% centrally funded schemes, subject to limits laid down in sub-rule (b) & (c), shall be given administrative approval by the Administrative Department and posed for funding by way of loans and grants from Government of India or any financing institution or agency without obtaining prior approval of the Public Investment Board. Further, no expenditure clearance for proposals above ₹300.00 lakhs shall be given by the Finance Department without the approval of the PIB.
- (b) Investment proposals for sums between ₹10.00 lakhs to ₹300.00 lakhs in respect of Non-Engineering Departments and ₹20.00 lakhs to ₹300.00 lakhs in respect of Engineering Departments shall vest with the Finance Department.
- (c) Investment proposals which are above ₹300.00 lakhs shall be placed before the Public Investment Board.
