No. 1/4/2008-FD(PIC)(PT)(3): The undersigned is directed to refer to the Manipur Services (Revised Pay) (Ist Amendment) Rules, 2011 and the Manipur Services (Revised Pay) (2nd Amendment) Rules, 2011, notified vide this Department's Notification No. 1/4/2008-FD(PIC)(Pt)(C), dated 09.06.2011 and 20.09.2011 respectively and to state that clarifications / points of doubts are being sought from various departments / quarters regarding mode of fixation of pay on account of further revisions of pay scale / Pay Band and Grade Pay in respect of posts annexed to therein.

2. In this connection, the following clarifications are issued :-

1.	For those who were / are still in service on or after 01.04.2010.	Ist fixation of pay shall be regulated as per rule 7 of the Manipur Services (Revised Pay) Rules, 2010 notified on 05.05.2010 for entitlements as per the said Notification. While regulating the pay, clarification under SI. No. 16 of this Department's O.M. of even number, dated 07.07.2010 shall be applied in respect of posts having downgraded scale of pay under O.M. No. 1/12/2006-FD(PIC), dated 28.12.2006. 2nd fixation of pay shall be regulated as per the Manipur Services (Revised Pay) (Ist Amendment) Rules, 2011 notified on 09.06.2011 or the Manipur Services (Revised Pay) (2nd Amendment) Rules, 2011 notified on 20.09.2011, as the case may be, for entitlements as per the said Notification. In both the cases, fixation of pay shall be regulated as per Note 1 below Rule 7(1)(C) [Illustration 2] of the Manipur Services (Revised Pay) Rules, 2010.
2.	How will the pay of Officers who were appointed / inducted to MFS with retrospective effect be regulated?	The pay of officers who were appointed retrospectively to MFS Grade-I, MFS Grade-II and MFS Grade-III, as the case may be, as per orders by the Department of Personnel, shall be fixed with reference to their existing pay as on the date of assumption of duty as per appointment orders, provided that —
		a) In case both the Pay Band and Grade Pay in the MFS Grade and existing post falls within the same Pay Band and Grade Pay, the same pay shall continue with the normal increment;
		b) In case of a higher Pay Band in the MFS Grade, rule 13 of the Manipur Services (Revised Pay) Rules, 2010 and clarification thereunder shall be followed.
