Subject :- Decision of the Government relating to the grant  
of various allowance to the serving Manipur Judicial  
Service Officers – clarifications thereof.

No. 1/8/2008-FD(PIC)(Pt.) : The undersigned is directed to refer to para 2 (g) of this Government Office Memorandum No. 1/8/2008-FD(PIC), dated 16/4/2011 in which it has been mentioned that the existing provisions of House Rent Allowance shall continue. In this connection, clarifications have been sought for regarding the rate of House Rent Allowance to be granted to the Manipur Judicial Service Officers who are not availing the Government accommodation after the introduction of Manipur Judicial Services (Revised Pay) Rules, 2011. The matter has been considered and it has been decided that Manipur Judicial Service Officers not availing a Government accommodation shall be entitled for H.R.A @ 10% of basic pay w.e.f. 1.1.2006 subject to other conditions as laid down in para 12 of OM No. 17/2/2005-FD(PIC), dated 17/4/2006.

Further, the Governor of Manipur is pleased to grant Special Compensatory Allowance @ Rs. 1500/- p.m. to all grades of Manipur Judicial Service Officers w.e.f. 1/1/2006. The payment of arrears for the above allowances for the period from 1/1/2006 to 28/02/2011 shall be regulated as per Rule 12 of the Manipur Judicial Services (Revised Pay) Rules, 2011.
