No. 4/83/2006-JudI/L-3 : In exercise of power conferred by sub-section (1) of section 36AB of the Drugs & Cosmetic Act, 1940 (Act 23 of 1940) and with the concurrence of the Chief Justice of the High Court of Manipur, the State Government hereby designate the Sessions Court at column II in the Schedule below as Special Court at column III for trial of offences relating to adulterated drugs or spurious drugs and punishable under clauses (a) and (b) of section 13, sub-section (3) of section 22, clauses (a) and (c) of section 27, section 28, section 28A, section 28B and clauses (b) of sub-section (1) of section 30 and other offences relating to adulterated drugs or spurious drugs under the above Act within the limits of territorial jurisdiction at column IV in addition to its normal functions and duties:-
