1. QUALIFYING REQUIREMENTS:-

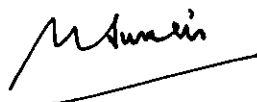
The Tenderers / Manufacturers meeting the following conditions only need apply.

1.1 CONSTITUTION OF BIDDER/ TENDERER

- Registered Manufacturer can only participate. Consortium of Firms / Manufacturers are not eligible.
- Registration Certificate of the Tenderer shall invariably be furnished.

1.2 TECHNICAL REQUIREMENTS

- The Tenderer should be Manufacturer of LT AC Static Energy Meters.
- The following qualifying requirement shall be fulfilled by the Tenderer
 - The Tenderer should have supplied a minimum of 5 lakh static meters with communication port facility till date of opening of bid.
 - The Tenderer should possess bureau of Indian standard certification (ISI Mark) for Meter manufactured in India..
 - The Tenderer should possess valid ISO 9001-2008 certification for meter manufacturing.
 - The Tenderer should not be black listed by any utility in India.
 - The Tenderer should have fully automatic test bench with reference standard meter of accuracy class not less than 0.2 or better.
 - The Tenderer should have NABL Approved testing laboratory and in-operation for last three years

1.3 COMMERCIAL & FINANCIAL REQUIREMENTS:-

- a) Annual turnover of the Tenderer should not be less than **Rs. 150.00 crore (one hundred fifty crore)** in each of the last three financial years. Certified balance sheet indicating the turn over for the same has to be attached.
- b) The Tenderer should submit complete annual report together with audited statements of accounts of the Manufacturer for last 5 (five) years immediately preceding the last date of receipt of request for issuing Tender Papers.
- c) The Tenderer should submit valid Income Tax, Service Tax, VAT/Sales Tax Registrations & PAN Card and PF, ESI code, labour license etc as applicable.

1.4 SUBMISSION OF DOCUMENTS FOR ISSUE OF TENDER PAPERS:

The Tenderer should furnish documentary evidence in support of the qualifying requirement stipulated as above.

The Tenderer, who wish to tender for the works, may submit their application request for issuing Tender Papers / Bidding Documents to the **Chief Engineer (Power), Electricity Department, Government of Manipur, Keishampat Electricity Complex, Imphal-795001** on or before the specified date.

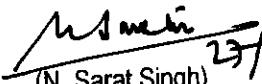
The application request along with the enclosures shall be submitted in a sealed envelope, which shall be super scribed "**REQUEST FOR TENDER PAPER, MANIPUR**" along with the Cost of the Tender paper (Non-refundable) shown above, in the form of Demand Draft from a Nationalized Scheduled Bank preferably having its branch at Imphal (preferably State Bank of India), drawn in favour of the **Executive Engineer, Imphal Electrical Division No. - I, Electricity Department, Manipur**.

Tender paper containing detailed Specification of the works along with Terms & Conditions will be issued to the qualified intending tenderers based on above criteria duly scrutinized by a Departmental Committee

The cost of Tender Papers / Bidding Documents shall be non-refundable. A self addressed envelope, cotton linen lined, of suitable size with sufficient stamp for sending the tender papers by **SPEED POST** or by **REGISTERED POST** for the areas not covered by Speed Post should also be accompanied with the application for purchase of Tender Papers / Bidding Documents.

Any delay / loss / non-receipt of the application for purchase of Tender Papers / Bidding Documents or of the Tender Papers/ Bidding Documents sold / issued or also in submission of completed Tenders due to Postal delay or any other reasons not attributable to the Department shall not be the responsibility of the Department and no time extension on these grounds shall be entertained.

The Department is not bound to accept the lowest tender / bid and reserves the right to reject any or all the Tenders or to accept any Tender in full or part thereof, without assigning any reason, whatsoever.
