No.4/33/2013-Judi/L: In exercise of the powers conferred by sub-section (1) of section 74 of the Food Safety and Standard Act, 2006(34 of 2006), the Governor of Manipur is pleased to constitute after consultation with the Chief Justice of the High Court of Manipur, the following Sessions Courts at column (ii) as Special Courts at column (iii) for trial offences relating to grievous injury or death of the customer for which punishment of imprisonment for more than three years has been prescribed under the aforesaid Act within the local limits of their territorial jurisdiction at column (IV) below:
