No. 2/13/2014-Leg/L : In exercise of the powers conferred by sub-section (1) of section 51 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (No. 30 of 2013), the State Government hereby establishes the Land Acquisition, Rehabilitation and Resettlement Authorities at column II in the Schedule below for the purpose of providing speedy disposal of disputes relating to land acquisition, compensation, rehabilitation and resettlement to exercise jurisdiction, powers and authority conferred on it by or under the Act and to specify the areas within which the authorities may exercise their jurisdiction for entertaining and deciding the references made to them under section 64 of the Act or applications made by the applicants under second proviso to sub-section (1) of section 64 as empowered by sub-section (2) of section 51 of the Act at column III and the ordinary place of sitting at column IV in the Schedule below :
