NOTIFICATION

Imphal, the 24th July, 2006.

No.3/1/2005-Act/L(LA): In exercise of the powers conferred by clause (1) of article 299 of the Constitution, the Governor of Manipur hereby directs that the undermentioned contracts and assurances of property made in exercise of the executive power of the State may be executed on his behalf subject to the stipulations made in para 8 below:-

1. All deeds and instruments relating to matters other than those specified in items 2 to 7 below ; by the Governor or any other officer authorized to authenticate orders and other instruments made and executed in the name of the Governor in accordance with rules made under clause (2) of article 166 of the Constitution.
2. Deeds, contracts and other instruments in matter connected with the sale of forest produce of all kinds; by the Deputy Conservator of Forest, Manipur.
3. Deeds, contracts and other instruments relating to: -
 - (i) execution of minor works for the Police Department not under the Public Works Department; and
 - (ii) supply of articles and medicines for use by the Manipur Rifles and any matters following within his ordinary jurisdiction by the commanding officer of the Battalion concerned.
4. Contracts for supply of articles for use in Jail or regarding the sale of articles manufactured in Jail; by the Inspector General of Prisons.
5. Contracts for supply of articles and medicines for use in Hospitals; by the Director of Health/Family Welfare, Manipur.
6. Contracts and other instruments for supply of articles and execution of works relating to the Public Works Department, Power Department, Public Health Engineering Department, Irrigation & Flood Control Department and Minor irrigation Department, by the Chief Engineer, the Additional Chief Engineer, the Superintending Engineer or the Executive Engineer, as the case may be, of the Department concerned.
7. Deeds and contracts for the supply of articles and execution of minor works not under the Public Works Department required for use of any department and other instruments connected with the administration of that department; by the Head of the Department concerned.
8. Signing of deeds, contracts and other instruments by officers mentioned in para 2 to 7 shall be subject to the following conditions:
 - (1) Deeds, contracts and instruments do not create liability or result in such commitments on behalf of the Government as are not clearly and explicitly approved by the Government in accordance with Rules of Business:

(2) Necessary administrative approval and expenditure sanctions for the contracts, deeds and instruments creating financial liability for the Government have been obtained in accordance with Delegation of Financial Powers Rules of the Government;

(3) All such contracts, deeds and instruments, creating financial liabilities are included in the approved work programme of the Department for the relevant year.

10. This supersedes all previous notifications issued in this regard.
