NOTIFICATION

Imphal, July 15, 2017

No. 100/3/2015-Law (14 FC): In exercise of powers conferred by sub-section (1) and (2) of section 3 of the Family Courts Act, 1984 (Act No. 66 of 1984), the State Government, after consultation with the High Court of Manipur, hereby establishes the following Family Court at column (I) for the purpose of exercising the jurisdiction and powers conferred on a Family Court within the local limits of the area to which the territorial jurisdiction shall extend, ordinary place of sitting and date of functioning of the Court as specified at column (II), (III) and (IV) respectively in the Schedule below:

2. Further, in partial modification of this Department's Notification No. 2/62/2012-Leg/L dated 25-02-2016, the territorial jurisdiction of the Family Court, Manipur shall be excluding the territorial jurisdiction of the Family Court, Imphal East.

3. The expenditure is debitable from the Head of Account namely Major Head 2014 Administration of Justice, Sub-Major 00, Minor 800 Other Expenditure, Sub-Head 06 Schemes under 14th FC Award, Detailed 00, Object 50 Other Charges under Demand no. 26 Administration of Justice.
