No. 5/1/2013-Casel/L(HC): In exercise of the powers conferred by clause (a) of sub-section (3) of section 7A of the Industrial Disputes Act, 1947 and with the concurrence of the Hon'ble High Court of Manipur, the Governor of Manipur is pleased to appoint Shri Justice Mutum Binoykumar Singh, former Judge of the Gauhati High Court as the Presiding Officer of the Industrial Tribunal, Manipur for adjudication of Industrial Disputes whether specified in the second schedule or the third schedule to the said Act and for performing such other functions as may be assigned to it under the Act, having jurisdiction throughout the whole of Manipur on payment of Rs. 5,000/- (Rupees five thousand) only at per day of sitting, until further order.

2. The Department of Commerce & Industry is to provide the remuneration of Presiding Officer and to provide Staff, Office Equipments, Stationery etc. for the Industrial Tribunal.

3. The Industrial Tribunal will sit at Room no. 138 New Secretariat, Minister Block, Imphal.
