Subject :- Decision of the Government relating to grant of Dearness Allowance to the State Government employees.


No. 2/6/2010-FD(PIC) : The undersigned is directed to say that consequent upon the introduction of Manipur Services (Revised Pay) Rules, 2010, the Governor of Manipur is pleased to order that the following rates of Dearness Allowance shall be admissible to all categories of State Government employees with effect from 01/04/2010 :-

Date of Effect	Rate of Dearness Allowance
01/01/2006	No Dearness Allowance
01/07/2006	2 % of basic pay
01/01/2007	6 % of basic pay
01/07/2007	9 % of basic pay
01/01/2008	12 % of basic pay
01/07/2008	16 % of basic pay
01/01/2009	22 % of basic pay
01/07/2009	27 % of basic pay
01/01/2010	35 % of basic pay

2. The term 'basic pay' in the revised pay structure means the pay drawn in the prescribed Pay Band plus the applicable Grade Pay but does not include any other type of pay like special pay, etc. For the purpose of calculation of Dearness Allowance, Non-Practising Allowance, where applicable, shall be taken into account as at present.

3. The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of FR 9(21).

4. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.

No. 3/1/2010-FD(PIC) : The undersigned is directed to say that consequent upon the introduction of Manipur Services (Revised Pay) Rules, 2010, the Governor of Manipur is pleased to order that the admissibility of House Rent Allowance (HRA) and Compensatory (City) Allowance (CCA) to the State Government employees with effect from 01/04/2010 shall be as under :-

- (i) Compensatory (City) Allowance (CCA) stands **ABOLISHED**.
- (ii) **House Rent Allowance (HRA) :**

2. The earlier classification of cities has been revised viz. A-1 to "X"; A, B-1 & B-2 to "Y" and C & Unclassified to "Z" and the rates of House Rent Allowance shall be as under :-

Classification of Cities / Towns	Rate of House Rent Allowance as a percentage of (Basic Pay + NPA where applicable)	Name of City
"X"	30%	Delhi (Urban Area) & Kolkata (Urban Area)
"Y"	20%	Guwahati (Urban Area)
"Z"	10%	Imphal and other areas of Manipur including Shillong and Vellore.

3. The term "basic pay" in the revised pay structure means the pay drawn in the prescribed Pay Band plus the applicable Grade Pay but does not include any other types of pay like Special Pay, etc.

4. In respect of those employees who opt to retain their pre-revised scales of pay, the pay for the purpose of these orders shall also include, in addition to the Basic Pay in the applicable pre-revised scales, Stagnation Increment(s), Dearness Pay and Non-Practising Allowance, where applicable, as per order in force on 01/04/2010.

5. All other conditions governing grant of House Rent Allowance under the existing orders shall continue to apply.

Government employees.

No. 4/1/2010-FD(PIC) : The undersigned is directed to say that consequent upon the introduction of Manipur Services (Revised Pay) Rules, 2010, the Governor of Manipur is pleased to decide that with effect from 01/04/2010 the Special Compensatory (Remote Locality) Allowance to the State Government employees including those serving at Guwahati and Shillong shall be admissible at the following rates :-

Category	Part - C [Entire State of Manipur] - Rupees per month	Part - D [Guwahati & Shillong] - Rupees per month
For posts in the Grade Pay of Rs. 5400 and above.	1500	400
For posts in the Grade Pay less than Rs. 5400.	1200	320

2. This Allowance supersedes all such allowances drawn in the past by the nomenclature of Difficult Area Allowance, etc.

3. In the case of those employees who opt to retain the pre-revised scale of pay, the corresponding Grade Pay of the pay scale/corresponding pay scale of the post occupied on 01/04/2010, as indicated in the Manipur Services (Revised Pay) Rules, 2010 would determine the allowance under these orders.
