No. 2/62/2012-Leg/L: In exercise of powers conferred by sub-section (1) of Section 3 of Prevention of Corruption Act, 1988 (49 of 1988), the Governor of Manipur is pleased to appoint the District & Sessions Judge, Ukhrul as the Special Judge of Ukhrul District (now Kamjong and Ukhrul Districts) to try the following offences, namely –

- (a) Any offence punishable under the Prevention of Corruption Act, 1988; and
