**ORDERS BY THE GOVERNOR : MANIPUR**

Imphal, the 12<sup>th</sup> July, 2012.

No. 1/4/2008-FD(PIC)(D) : WHEREAS the Manipur Services (Revised Pay) Rules, 2010 had been issued under Notification No. 1/4/2008-FD(PIC), dated 05/05/2010, published in Manipur Gazette Extraordinary No. 12, dated 05/05/2010 revising the pay scales of the employees under the Government of Manipur notionally from 01/01/2006 with cash payment from 01/04/2010 ;

2. AND WHEREAS the Chief Engineer, Public Works Department, Manipur, vide his letter No. 36/1/2010-CE/1332, dated 06/12/2010, pointed out that, among others, the posts of Section Officer Grade-I (Mechanical), Section Officer Grade-II (Mechanical) and Architecture Draftsman and their revised Pay Band and Grade Pay had been omitted in the Schedule to the said Rules, 2010 and requested for inclusion of the said posts in the said pay revision ;

3. AND WHEREAS the said posts of Section Officer Grade-I (Mech) and Architecture Draftsman had not been included in the Schedule to the Manipur Services (Revised Pay) (2<sup>nd</sup> Amendment) Rules, 2006, published in Manipur Gazette Extraordinary No. 501, dated 08/03/2007 further revising the revised pay scales under the Manipur Services (Revised Pay) Rules, 1999 corresponding to the pre-revised scales under the Manipur Services (Revised Pay) Rules, 1990 wherein the revised pay scale of (i) Rs. 5000-8000 ; and (ii) Rs. 5500-9000 [after 10 years of regular service in the grade] for the post of Section Officer Grade-I (Civil / Elect) had been further revised downward to (i) Rs. 4500-7000 ; and (ii) Rs. 5000-8000 [after 10 years of regular service in the grade] ;

4. AND WHEREAS Order No. 1/4/2008-FD(PIC)(D), dated 21/09/2011 had been issued providing appropriate revised Pay Band and Grade Pay in respect of the posts omitted or left out in the said Rules, 2010, in which Pay Band 9300-34800 + GP 4200 and GP 4300 [after 10 years of regular service in the grade] had been provided for the omitted posts of Section Officer Grade-I (Mechanical) and Architecture Draftsman since the same had not been included in the downgradation of pay scales under the Manipur Services (Revised Pay) (2<sup>nd</sup> Amendment) Rules, 2006 ;

5. AND WHEREAS the revised Pay Band and Grade Pay shown in the said order, dated 21/09/2011 had been made effective notionally from 01/01/2006 with cash payment from 01/04/2010 while the Manipur Services (Revised Pay) (1<sup>st</sup> Amendment) Rules, 2011 restoring the downgraded pre-revised pay scales of deserving cases like the posts of Section Officer Grade-I (Civil / Elect) and prescribing the appropriate revised Pay Band and Grade Pay had been made effective notionally from 01/01/2006 with cash payment from 01/07/2011 ;

6. AND WHEREAS the All Manipur Engineering Department Section Officers' Co-ordination Committee (AMSOC) had submitted a representation, dated 11/12/2011 pointing out, among others, the disparity amongst the Grade-I Section Officers and treatment of equals as unequals ;

7. AND WHEREAS, on minute examination of the matter, it has been found that the nomenclatures of Section Officer Grade-I (Mechanical), Section Officer Grade-II (Mechanical) and Architecture Draftsman in the Public Works Department, Government of Manipur had not been included in the Schedules to the Manipur Services (Revision of Pay) Rules, 1975 and 1982 and the Manipur Services (Revised Pay) Rules, 1990 and 1999 ;

8. AND WHEREAS the Engineering Departments under the Government of Manipur had been requested vide letter No. 1/14/2012-FD(PIC), dated 20/04/2012 and reminded on 27/04/2012, 10/05/2012 and 30/05/2012 [Last Reminder] to furnish the details of posts of Section Officer Grade-I (Mechanical), Section Officer Grade-II (Mechanical) and Architecture Draftsman viz. creation of posts, drawal of pay and allowances under the previous Revision of Pay Rules etc. ; but, except the Public Health Engineering Department, Manipur, which has informed that there are no posts of Section Officer Grade-II (Mechanical) and Section Officer Grade-I (Mechanical), no one has complied with the above instructions till date ;

9. AND WHEREAS it has been decided that prescription of revised Pay Band and Grade Pay for the similar posts of Section Officer Grade-II (Civil / Electrical / Mechanical), Section Officer Grade-I (Civil / Electrical / Mechanical) and Draftsman Grade-I / Architecture Draftsman with different effective dates of cash payment is not proper ;



NOW, THEREFORE, the Governor of Manipur is pleased to order that the revised Pay Band, Grade Pay and effective date of pay revision and cash payment in respect of the omitted posts of Section Officer Grade-I (Mechanical), Section Officer Grade-II (Mechanical) and Architecture Draftsman appearing at Sl. No. 6, 7 and 8 of I. COMMON FOR ALL ENGINEERING AND OTHER DEPARTMENTS of this Government Order No. 1/4/2008-FD(PIC)(D), dated 21/09/2011 shall be as follows at par with those of Section Officer Grade-I (Civil / Elect) and Draftsman Grade-I :-
