No. 1/18/2003-PIC : In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Manipur hereby makes the following rules to amend the Manipur Judicial Services (Revised Pay) Rules, 2011 namely :-

1. (1) These rules may be called the Manipur Judicial Services (Revised Pay) (Amendment) Rules, 2012.

(2) These rules shall be deemed to have come into effect on the 1<sup>st</sup> day of January, 2006.

2. In the third line of sub-rule (iii) of rule 3 of Manipur Judicial Services (Revised Pay ) Rules, 2011, insert the word "Judicial" in between the words "Manipur " and "Services".

(2) Delete the provisions of sub-rule (a) of rule 7 of these rules and there will be no sub-rule (b) except the following paragraph –

"There will be no fitment or fixation of pay given one or more increment(s) or additional weightage. The pay drawn in the existing scale of pay specified in column (2) of the pay stages in Table below will correspond in the same stage in the revised scale of pay specified in column (4) thereof with increment."
