NOTIFICATION Imphal, the 15th August, 2008

No.18/94/2008(MJS)/DP (B): Pursuant to the Orders dated 04-01-2007 and dated 24-07-2008 passed by the Hon'ble Supreme Court of India in Civil Appeal No. 1867 of 2006 [Malik Mezhar Suitan & ann. — vs — U.P. Public Service Commission & Ora] and in exercise of the powers conferred by the proviso to Article 309 read with Article 234 of the Constitution of India, the Governo: of Manipur, in consultation with the Gauhatt High Court and the Manipur Public Service Commission, is pleased to make the following Rules to amend the Manipur Judicial Service Rules, 2005, namely,—

THE MANIPUR JUDICIAL SERVICE (THIRD AMENDMENT) RULES, 2008

- Short title and commencement:
 —
 (1) These Rules may be called the Manipur Judicial Service (Third Amendment) Rules, 2008.
 - (2) They shall come into force with effect from the date of its publication in the official Gazette.
- Amendment of Rule 10: In Rule 10 of the Manipur Judicial Service Rules, 2005 (hereinafter referred to as the principal Rules),-
 - (a) sub-rule (1) shall be deleted;
 - (b) the existing sub-rule (2) shall be renumbered as sub-rule (1);
 - (c) the following provision shall be added as new sub-rule (2), namely,-
 - "(2) All vacancies in all grades of service either by promotion or direct recruitment, as may be, shall be filled up in accordance with the time schedule mentioned in Schedule-BB."
- 3. Amendment of Rule 10A :- Rule 10A shall be deleted.
- 4. Substitution of Schedule BB :- For Schedule BB of the principal Rules, the following shall be substituted, namely,-

"SCHEDULE - BB"

- A. For filling of vacancies in the Cadre of Grade-I in respect of:
 - (a) twenty five percent vacancies to be filled by direct recruitment from the Bar; and

(b) twenty five percent by promotion through limited competitive examination of Civil Judges (Senior Division) not having less than five years of qualifying service
