No.9/19/2010-FD(PIC)(LP): The undersigned is directed to refer to the above subject and to say that in pursuance of Government's decision following the introduction of the Manipur Services (Revised Pay) Rules, 2010 vide Notification No.1/4/2008-FD(PIC), dated 05/05/2010, the Governor of Manipur is pleased to clarify that Liberalised Family Pension / Death Gratuity of the Government employees who died during the period from 01/01/2006 to 31/03/2010 as a result of violence/ wrongful acts of member/ members of some extremist organizations/ anti-social elements or during action against dacoits, smugglers, hostiles, etc. and whose amount of family pension had been sanctioned by the Government on the basis of pay last drawn under Manipur Services (Revised Pay) Rules, 1999 i.e. before the publication/implementation of Manipur Services (Revised Pay) Rules, 2010 shall be calculated/ revised on the basis of the notional pay w.e.f. 01/01/2006 or from the date of death, whichever is later, under the Manipur Services (Revised Pay) Rules, 2010 with actual cash payment from 01/04/2010 or 01/11/2010 or 01/09/2011, as the case may be.
