Imphal, the 1st April, 2011.

Subject :- Revision / modification of family pension of pre-2006 Family pensioners under the Manipur Services (Liberalised Pension) Rules, 2000.

No. 9/19/2010-FD(PIC)(LP): The undersigned is directed to say that in pursuance of Government's decision following the introduction of the Manipur Services (Revised Pay) Rules, 2010, the Governor of Manipur is pleased to introduce the following revision/modifications in the rules regulating Family Pension under the Manipur Services (Liberalised Pension) Rules, 2000 for implementation to the family pensioners of the expired Government employees of the State Government.

2. These orders apply to all family pensioners who were drawing family pension on 01/01/2006 under the Manipur Services (Liberalised Pension) Rules, 2000.

3. In these orders :


- (a) Existing Family pensioner means a family pensioner who was drawing/entitled to family pension on 31/12/2005.
- (b) Existing family pension means the basic family pension drawn on 31/12/2005 under the Manipur Services (Liberalised Pension) Rules, 2000.

4. The family pension of existing pre-2006 family pensioners will be consolidated with effect from 01/01/2006 by adding together :-

- (i) Result of multiplication of existing family pension by a factor of 1.86; and
- (ii) Fitment weightage @ 40% of the existing family pension.

While calculation of both (i) & (ii) above, fractions of 50 paise and above shall be rounded off to the next higher rupee and the fractions of less than 50 paise shall be ignored.

The amount so arrived at will be regarded as consolidated family pension with effect from 01/01/2006, notionally with effect from 01/01/2006 with cash payment/ actual benefit from 01/04/2010.

5. The quantum of family pension available to the old family pensioners shall be increased as follows :-


Age of family pensioner	Additional quantum of family pension
From 80 years to less than 85 years	20% of revised basic family pension
From 85 years to less than 90 years	30% of revised basic family pension
From 90 years to less than 95 years	40% of revised basic family pension
From 95 years to less than 100 years	50% of revised basic family pension
100 years or more	100% of revised basic family pension

The amount of additional family pension will be shown distinctly in the Pension Payment Order (PPO). For example, in case where a family pensioner is more than 80 years of age and his/ her consolidated family pension in terms of para 4 above is Rs.10,000/- p.m., the family pension will be shown as (i) Basic family pension = Rs.10,000/- and (ii) Additional family pension = Rs.2,000/- p.m. The family pension on his/ her attaining the age of 85 years will be shown as (i) Basic Family Pension = Rs.10,000/- and (ii) Additional Family Pension = Rs.3,000/- p.m.

5.1 Where the consolidated family pension in terms of paragraph 4 above works out to an amount less than Rs.3,500/- the same shall be stepped upto Rs.3,500/-. This will be regarded as family pension with effect from 01/01/2006.

6. All Pension Disbursing Authorities including Public Sector Banks handling disbursement of family pension to the family pensioners of the expired Government servants are hereby authorized to pay family pension to existing family pensioners at the consolidated rates in terms of para 4 above **only after authorization from the Treasury Officer concerned subject to furnishing, later on, to the Office of the Accountant General (A&E), Manipur the Statement of Consolidated Family Pension within 6(six) months for verification.** Wherever the age of family pensioner is available on the Pension Payment Order (PPO), the additional family pension in terms of para 5 above may also be paid by the Pension Disbursing Authorities **immediately on receipt of authorization from the Treasury Officer concerned.** A suitable entry regarding the revised consolidated family pension shall be recorded in both halves of the Pension Payment Order.

7. The consolidated family pension as worked out in accordance with provisions of Para 4 above shall be treated as final 'Basic Family Pension' with effect from 01/01/2006 and shall qualify for grant of Dearness Relief sanctioned on or after 01/04/2010.
