### 2. <u>Eligibility condition</u>:

(a) Should not have attained/exceed 65 years (age).

### (b) Other essential qualification:

- i. The person should be a Citizen of India.
- ii. Degree in any discipline.
- iii. The person should not be of unsound mind, insolvent or convicted for any crime.
- iv. The person should not be a Member of Parliament or Member of the Legislature of any State or Union Territory or hold any other office of profit or connected with any political party or carrying on any business or pursuing any profession.

#### (c) Experience (Desirable):

- i. Persons of eminent standing and impeccable integrity with atleast 30 years of work experience in Public Administration, Law, Academics, Social Work, Management, Journalism or Mass Media with proven administrative capabilities.
- ii. Be able to provide leadership by his own example.
- iii. Be able to provide vision and have ability to translate the same into reality in the interest of public.
- iv. Be able to interact effectively and persuasively with a strong knowledge-base at senior levels and in large forums as well as on a one to one basis.

#### 3. <u>General Conditions for Recruitment:</u>

- i. Candidates must fulfill qualification and experience on the date of application. Educational qualification must have been obtained from recognized University/ Institute/Board/College only.
- ii. Qualifications and experience may be relaxed at the discretion of the 'Committee' for applicants having brilliant service record.
- iii. Essential qualifications/experience mentioned is the minimum and mere possession of them will not entitle an applicant to be considered for appointment automatically. If the number of applications received is large and it is not convenient for the 'Committee' to consider all applicants, the number of candidates may be restricted to a reasonable limit on the basis of qualifications and experience.

- Selection/appointment/employment will be subject to fulfillment of required qualifications, experience etc., as also to verification of testimonials, antecedents and past service. If it is found, at any stage, that any information has been suppressed or wrongly/falsely provided or any fraud has been committed, the selection/appointment/employment of the concerned applicant will be rejected/cancelled/terminated summarily.
- 4. Applicants should fulfill the eligibility criteria and general condition of recruitment indicated in Paras -2 & 3 above.
