No. 5/5/2011-Power(B): Whereas, the Electricity Department, Manipur (EDM) has been unbundled into 2 (two) successor Companies namely (1) Manipur State Power Company Limited (MSPCL or HOLDCO) and (2) Manipur State Power Distribution Company Limited (MSPDCL or DISCOM) w.e.f. the 1st of February, 2014 under Section 131 and 133 and other applicable provisions of the Electricity Act, 2003 by notifying the Manipur State Electricity Reforms Transfer Scheme, 2013 on the 31st of January, 2014;

Whereas, financial transactions of the erstwhile DDOs were allowed to be continued by the Government till the 31st of March, 2014;

Whereas, there were 36 (thirty six) nos of Drawing and Disbursing Officers (DDOs) of the Electricity Department, Manipur and out of which 27 (twenty seven) nos of Divisions [as given below] were submitting separate Divisional Accounts to the Office of the Accountant General, Manipur under intimation to the state Finance Department, Manipur as per the provisions laid down in Central Treasury Rules, CPWD manual and the remaining 9 (nine) nos of DDOs operate only establishment related bills through the Treasury/Sub-Treasury Offices.

Whereas, there shall be only 2 (two) DDOs retained with the Electricity Department, Manipur namely the Administrative Officer (Power), Manipur and the Executive Engineer (MRT) Manipur while all the remaining 34 Nos of DDOs shall cease to operate and their DDO Codes will be kept in abeyance until further orders.

Now, therefore, all important works of the Department including Transmission, Generation, Distribution, etc shall be taken up by Concerned Company and the Department will not be required to draw using Government PWD Cheques. Further, all the 27 Divisions of the Department shall ceased to operate Cheque Drawl Authority w.e.f. 1st of April, 2014 and hence no Divisional Accounts of the above mentioned 27 DDOs from the month of April, 2014 shall be submitted to the Office of the Accountant General, Manipur.
