- 2. Accordingly, the tenability of these objections were examined in comparison with the documents forwarded by the respective Deputy Commissioners in whose districts the District Programme Management Units (DPMUs) under ePanchayat MMP are to be set up.
- 3. On the basis of this exercise, it has been confirmed that some of the candidates do not possess the **requisite essential educational qualifications** for the said post(s) to which they had applied, and the objections are therefore upheld.
- 4. The essential qualification for the said post(s) are provided in the notification No.1/12/2012-RD(MGNREGA) dated 02.01.2014 and is reproduced in the table below (Table A).
