- 5.1 Registered Manufacturer can only participate. Consortiums of Firms/company/manufacturers are not eligible.
- 5.2 Registration Certificate of the Tenderer shall invariably be furnished.

6.0 QUALIFICATION OF THE BIDDER

This section covers the minimum requirements with respect to experience, capability, financial and other particulars of the Bidder to be considered eligible for participation in the bid for the proposed metering work. The BIDDER shall become eligible to bid on satisfying the following "BID QUALIFICATION REQUIREMENTS" and on production of the required documentary evidences along with the Tender.

6.2 TECHNICAL EXPERIENCE:

- 6.2.1 The Bidder should be Indian Meter Manufacturer only. The meter manufacturer who supplies the meters should have a minimum experience of 5 years of manufacture, supply, erection, testing and commissioning of such meters.
- 6.2.2 The bidder shall have supplied minimum 1000 nos. of Class 0.2 Meters to different electrical utilities directly in India in last 5 years and performance certificates of at least 500 nos. from different utilities shall be submitted with the bid.
- 6.2.3 The bidder must have manufactured and supplied minimum quantity of 5000 Three phase HT 0.5 class trivector fully static energy meter with LCD display & optical communication port in each of last three financial years. Documentary evidence shall be provided along with the bid such as Supply details, P.O. Copies, etc.
- 6.2.4 The Bidder must possess bureau of Indian Standard Certification (ISI mark) for meter manufactured in India.
- 6.2.5 The bidder must possess valid ISO 9001:2008 certification for meter manufacturing, ISO 27001:2005 for information security management system & ISO 14001:2004 for environmental management system.
- 6.2.6 The Bidder must have NABL accredited for laboratory and in operation for last three years. Documentary evidence of the same shall be submitted alongwith the bid.
- 6.2.7 The bidder should not blacklisted by any utility in India
- 6.2.8 The Bidder should have fully automatic test bench with reference standard meter of accuracy class not less than 0.2 or better.

6.3 FINANCIAL POSITION:

- 6.3.1 Annual turnover of the firm should not be less than Rs. 10.00 Crores in each of the last 3 (three) financial years in respect of metering business only. Certified balance sheet for the same has to be attached.
- 6.3.2 The Tenderer should submit complete annual report together with audited statements of accounts of the Manufacturer for last 3 (three) years immediately preceding the last date of receipt of request for issuing Tender Papers.
- 6.3.3 The Firm / Company shall be financially sound and must have sufficient funds to deploy in the work. A certificate from the Banker indicating various <u>fund based</u> / <u>non fund based</u> limits sanctioned to them and extent of utilization as on date shall be furnished.
- 6.3.4 The Firm / Company shall submit details of technical staff to work at site

7.0 SUBMISSION OF DOCUMENTS

- 7.1 The Firm / Company shall furnish documentary evidence in support of the qualifying requirement stipulated as above.
- 7.2 The Firms / Companies, who wish to purchase Bidding Documents, may submit their (PQ) application to the Managing Director, Manipur State Power Company Limited (MSPCL), Manipur, Keishampat, Imphal 795001 along with Cost of Tender on or before the specified date i.e. 31.01.2015 upto 14.00 hrs (IST).
- 7.3 The application along with <u>PRE-QUALIFYING (PQ) REQUIREMENTS</u> and <u>COST OF TENDER</u> shall be submitted in a sealed envelope, which shall be superscribed "REQUEST FOR BIDDING DOCUMENT". PQ Requirement Data Sheet is enclosed as Annexure I.

- 7.4 The Firm/Company shall submit 2 (sealed) Tender in separate cover superscripted as Cost of Tender Form in the 1st cover and 2nd as Pre-Qualification (PQ) Requirement to the MSPCL. The 2nd cover shall not be opened if cost of tender is not found in the 1st Cover.
- 7.5 Intimation to the qualified firms/company will be sent individually on **05.02.2015**. Bidding Documents shall be issued only those qualified Firms/Company and the same can be downloaded from the portal https://www.manipurtenders.gov.in. Bidders to note that for participating in bidding they are required to register themselves with NIC, Manipur at portal https://www.manipurtenders.gov.in before **05.02.2015**. The said registration with NIC shall be free of cost. - 7.6 The Firm/Company should submit their **Bid** through electronic mode only.
- 7.7 Security Bid/Earnest Money Deposit of Rs. 3.00 Lakhs in the form of Demand Draft /BG from a Nationalized /Scheduled Bank having its branch at Imphal (preferably State Bank of India), to be drawn in favour of Managing Director, Manipur State Power Company Limited, Imphal.
- 7.8 A Demand Draft of Rs. 20,000/- towards the cost of tender paper, drawn in favour **Managing Director**, **Manipur State Power Company Limited**, **Imphal** shall be submitted along with PQ Requirements/Application for each specified work.
- Original copy of Security Bid/Earnest Money Deposit (EMD), Power of Attorney, Guaranteed Technical Particulars (GTP) of equipments/materials etc. should be submitted to Managing Director, Manipur State Power Company Limited, Imphal on or before 13.02.2015 upto 14.00 hrs (IST). If Earnest Money Deposit/Bid Security is not found, their bids shall not be considered.
