Mo.1/17/2000-FC: It has come to the notice of the Government that several Drawing & Distrusing Officers of the Government Departments have drawn funds from the Treasury/authorized Bank through bills or cheques and retained funds either in form of Bankers' cheque or D-at-Calls and/or kept such funds in accounts opened in the Banks without permission of the Government.

Attention is drawn in this legard to the Orders of Government issued vide even number dated 20-09-2001 placing a complete ban on holding of funds/money by Department outside the Government account in form of Bankers' cheques/D-at-Calls.

It is reicasted that holding of funds in Bankers' cheques/D-at-Calls and/or unauthorized Bank accounts by any Drawing & Disbursing Officer is violative of the Central Treasury Rules as adopted by the Government of Manipur and renders such DDOs/Heads Of Office to administrative/disciplinary action.

It is accordingly decided that all DDOs shall immediately deposit all funds new in form of Bankers' cheques, D-at-Calls or Bank accounts into Government account latest by 15th November, 2006 and the details of such funds he'r/deposited shall be furnished to the Finance Department latest by 20th November, 2006. The concerned Heads of Department shall compile the details of such deposits and furnish the information to Finance Department in a consolidated manner.

It is further ordered that in future, no each funds in form of Banker's cheques, D-at-Calls or Bank Account shall be held/opened without specific permission of the Finance Department.
