The said registration with NIC shall be free of cost. Those who are qualified firms/company can link the portal for downloading Bidding Documents any time from **17.00 hrs (IST) on 28.02.2015 to 14.00 hrs (IST) on 09.03.2015**.
- 7.9 Original copy of Security Bid/Earnest Money Deposit (EMD), Power of Attorney, Guaranteed Technical Particulars (GTP) of equipments/materials etc. should be submitted to **Managing Director, Manipur State Power Company Limited, Imphal** on or before **09.03.2015 upto 14.00 hrs (IST)**. If Earnest Money Deposit/Bid Security is not found, their bid shall not be considered.
