ORDERS BY THE GOVERNOR : MANIPUR

Imphal, the 3rd June, 2011.

Subject :- Setting up of a Central Committee to examine cases on Pay Anomaly.

No.1/4/2008-FD(PIC)(Pt.(C) : In pursuance of Cabinet decisions taken on 02/06/2011, the Governor of Manipur is pleased to constitute a Central Committee consisting of the following Officers to examine the under-mentioned terms of reference on Pay Anomaly :

2. The terms of reference of the Central Committee shall be as follows :-

- i) re-look the provisions of the existing Recruitment Rules and suggest modification in order to ensure merger of posts to de-layer the hierarchies and re-structuring of hierarchies in each Department to avoid multiple channels of promotion ;
- ii) examining the feasibility of providing appropriate pay scale considering the qualifications, job-requirements, hierarchical relativities, re-designation of posts / restoration of earlier nomenclature, etc. in respect of left out cases, if any ;
- iii) examining the feasibility of delinking of all Group D staff from feeder to Group C posts as stagnation is taken care of by the Modified Assured Career Progression ;
- iv) examining the feasibility of removing the direct recruitment quota at every stage in the hierarchies in the Department ;
- v) avoidance of prescription of qualification like Post Graduate or Graduate, Diploma or Certificate for recruitment or promotion to a post, only the minimum qualification may be incorporated ;
- vi) examining the financial implication and feasibility of rationalising the posts of Deputy Directors and analogous posts in all the Departments at 9300-34800 + GP 5400 corresponding to pre-revised scale of Rs. 8000-13500 as provided under the Manipur Services (Revised Pay) Rules, 1999 ;
- vii) examining the financial implication and feasibility of restoring Group A status prevailing in RPO, 1975 to the posts of Assistant Director and analogous posts in all the Departments by providing 9300-34800 + GP 4400 corresponding to pre-revised scale of Rs. 6500-10500 ;

- viii) examining the financial implication and feasibility of restoring Group-B status prevailing in ROP, 1975 or 1982 to the posts like, Inspector [other than Civil Police], Extension Officer (Ind. / Dev. / Panchayat etc.), Progress Assistant, etc. ;
- ix) examining the financial implication and feasibility of restoring Group-C status prevailing in ROP, 1999 to the posts like, Fireman, Constable (Excise), Laboratory Attendant (W&M), Forrest Guard, etc. ;
- x) examining the feasibility of removing pay anomaly arising out of Supervisors of ICDS drawing higher pay scale than those in the Centre ;
- xi) working out financial implication of various recommendations of the Sub-Committee and examining the feasibility of implementing those recommendations ;
- xii) all redundant posts in various Departments may be abolished. LDCs and Daftry may be declared as dying cadres. The clerical level entry may start with Office Assistant having a minimum working knowledge of operating computers and its peripherals ;
- xiii) level jumping of 3 or more stages in various promotion shall be avoided ; and
- xiv) Class 12th standard may be fixed as the minimum entry qualification for Group C posts.

3. The Committee shall submit its Report to the Government within 4(four) months from the date of issue of these orders.
