No. 2/4/99-FD(PIC)(Pt): The under gned is directed to refer to this Government Office Memorandum No.2/4/99-FD(F C)(Pt), dated 25.09.2007 and No. 9/92/99-FD(PIC)(Pt), dated 25/09/2007 regal ing the above subject and to state that the Governor of Manipur is pleased to excide that the Dearness Allowance/Dearness Relief payable to the State Governor ent ϵ mployees/Pensioners/Family Pensioners shall be enhanced from the existing rale of 35% to 47% with effect from 01.07.2008.

- 2. The term 'Pay' for the purpose of calculation of Dearness Allowance shall be the pay drawn in the prescribed scale of pay including stagnation increment and Non-Practicing Allowance; but shall not include any other type(s) of pay like Special Pay (since suspended), Personal Pay etc. Allowance/Dearness Relief is computed on the basis of basic pay/pension, dearness pay/pension, stagnation increment and the basis of basic pay/pension, dearness NPA. In case of Medical & Veterinary Doctors (including Homeopathy & Nature Cure in this Government Office Memorandia hold good. In the case of those who open the limit of Pay plus DA and NPA as laid down in of even number, dated 25.09.2007 shall still hold good. In the case of those who open to reven number, dated 25.09.2007 shall still hold good. In the case of those who open to retain the existing scale of pay (Pre-revised nearly prevised scale, Dearness Allowance and Interim Relief appropriate to that pay admissible under order in existence as on 01/01/1996.
- 3. The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of FR 21.
- 4. Payment on account of Deaness Allowance/Dearness Relief involving a fraction of 50 paise and above shall be rounded off to the next higher rupee and the fraction of less than 50 paise shall be innored.
