# ORDERS BY THE GOVERNOR: MANIPUR

Imphal, the 30<sup>th</sup> April,2009.

No. 5/6/2006-FC(Pt.I)/1: In pursuance of the Cabinet Decision taken on 29/4/2009, the Governor of Manipur is pleased to order the following:

- i) Manipur Police Housing Corporation(MPHC), Planning and Development Authority(PDA), Manipur Development Society(MDS) and Manipur Tribal Development Corporation(MTDC):
  - a) These entities will continue with their construction works taken up as "Deposit Works" from different departments till now. In future they must first concentrate on their core activity, i.e., Police buildings by MPHC, Tribal Welfare Buildings by MTDC, MAHUD buildings by PDA and own work programme by MDS. "Deposit works" from other departments should be taken up only after the PWD gives a "no-objection" and after having satisfied their Administrative Department concerned that additional work could be taken up by the Agency without affecting the work programme of the parent department.
  - b) The above agencies will obtain proper architectural design approval from the client department and technical approvals from the competent authority in the Government before they undertake any deposit work. All administrative departments will ensure that these approvals are obtained before sanction and award of work.

## ii) Manipur Industrial Development Corporation(MANIDCO):

No further deposit work will be taken up by MANIDCO except in respect of Commerce and Industries Department. Deposits of other departments made till now and for which work has not commenced as per the approval of the competent authority in the corporation should be refunded to the depositing department. MANIDCO will be allowed to complete the works for which the progress is 50 percent or more only after getting the clearance of the Committee constituted under this Government Orders No.5/6/2006-FC(Pt.I) dated 30/4/2009. Such balance works will be completed within one month of the clearance of the Committee.

#### iii) Engineering Cells of District Councils:

No further deposit work will be taken up by the two Engineering Cells of District Council (Wing-I and Wing-II) from any other department of the Government. These two wings may be merged with MTDC for which the Hills Department will work out the modalities immediately in consultation with Finance Department and Department of Tribal Development.

# iv) Technical Promotion Cell (TP Cell):

TP Cell is a non-Government entity and stands wound up with immediate effect. The Cell will be allowed to complete the works for which the progress is 50 percent or more only after getting the clearance of the Committee constituted under this Government Orders No.5/6/2006-FC(Pt.I) dated 30/4/2009. Such balance works will be completed within one month of the clearance of the Committee.

# v) District Rural Development Agencies(DRDAs):

Henceforth the DRDA will not accept any deposit works of other Departments the cost of which exceeds the technical powers of Executive Engineers.

These orders shall take immediate effect.
