OFFICE MEMORANDUM
Imphal, the 13th October, 2008.

Subject : - Age-limit for dependent children of Government servants and pensioners for availing medical facilities.

No. 6/15/99-FD(PIC)(Pt-I)(D) : The undersigned is directed to state that the age-limit for dependent sons and daughters was earlier fixed vide Office Memorandum of even number, dated 03/09/2007 according to which for sons to be dependent on his father/mother, he had to be less than 25 years of age or till he started earning, whichever was earlier. Attention of this Government has been drawn to the fixation of upper age-limit for admissibility of medical reimbursements in respect of sisters/ brothers.

2. The matter has been under consideration of the Government for quite some time and, now, the Governor of Manipur is pleased to re-fix the age limit for dependants, as indicated below : -

1. Son	Till he starts earning or attains the age of 25 years, whichever is earlier.
2. Daughter	Till she starts earning or gets married, irrespective of the age-limit, whichever is earlier.
3. Son suffering from any permanent disability of any kind (physical or mental)	Irrespective of age limit.
4. Dependent divorced/abandoned or separated from their husband/widowed daughters and dependent unmarried/divorced/abandoned or separated from their husband/widowed sisters.	Irrespective of age-limit.
5. Minor brother (s)	Up to the age of becoming a major (18 years).

3. The other conditions of dependency and normally residing with the Government servant will remain the same.

4. This order will take effect from the date of issue of the Office Memorandum.
