Now-a-days, for air traveling, e-ticket is widely used by various airlines and at the time of claiming T.A., it has become very difficult to ascertain whether the incumbent has actually performed the journey by air or not. It would be ideal if submission of boarding pass along with e-ticket is made mandatory to check irregularity while claiming T.A. as the extent rules do not provide that boarding pass should be furnished to buttress the claims

2. The matter has been considered by the Government for quite some time and now, the Governor of Manipur is pleased to order that boarding pass should be submitted along with the e-ticket by the State Government employees while claiming for refund of TA.
