No.6/262/2015-DTSM: In accordance with the decision of Organising Committee of Manipur Sangai Festival 2015, the art, craft, tradition and culture of various communities of the State are being showcased in the form of traditional exhibition huts in the northern half of Hapta Kangjeibung, Palace Compound.

2. In this connection, Department of Tourism, Government of Manipur invites detailed proposals from creative, reputed, eligible, artistic Firms/Agencies to partner the State Government in showcasing the rich State legacy of heritage, culture, art and craft through the design and construction of traditional exhibition huts representative of various communities and their ethnicities.

3. Interested Firm should come up with innovative and creative ideas for showcasing the rich heritage and tourism potential of all the communities of the State in artistic form through 15 (fifteen) traditional exhibition huts. The techno-commercial proposal should also contain a Power Point/multimedia Presentation containing details of design of the huts, specifications, materials to be used, cost of construction and maintenance of each hut during the period of the festival.

4. Interested Firms/Agencies should also present a vision in terms of layout, natural landscaping and presentation of flora, fauna and other aspects of the State to ensure Manipur is projected and promoted as a preferred global tourist destination.

5. The proposals should reach the Office of the undersigned during office hours by 4:00 pm of 10.10.2015. The Presentation before Secretary (Tourism), Government of Manipur in her office at South Block, Old Secretariat, Imphal will be held on 11.10.2015 (Sunday) at 11:00 am.
