No. 32/9/2016-DIT: Notification of even number dated 22nd March, 2016 inviting bids for connecting the State Wide Area Network (SWAN) Points of Presence (POPs) at the State HQ and District HQs to State Government offices on Optical Fiber Cables (OFC) stands cancelled and bids are re-invited from interested parties for connecting the State Wide Area Network (SWAN) Points of Presence (POPs) at the State HQ, District HQs and 3 (three) Block HQs to State Government offices on Optical Fiber Cables (OFC). The number of Offices may be increased or decreased depending on the site feasibility and requirements from different Departments and the item requirement may increase or decrease accordingly. **SCOPE OF WORK FOR CONNECTING SWAN POPs TO STATE GOVERNMENT OFFICES
AT STATE HQ, DISTRICT HQ AND 3 BLOCK HQ.**

1. All offices of the Government of Manipur in Imphal West and Imphal East are to be connected to the State Wide Area Network (SWAN) Network Operating Centre (NOC) at the State Data Centre.
2. All offices of the Government of Manipur at the District HQs and 3 Block HQs other than Imphal West and Imphal East will be connected to the respective SWAN Point of Presence (POP) at the District HQ and Block HQ.
3. Last mile connectivity to each office will be on Optical Fiber Cable (OFC) and using Gigabit Passive Optical Network (GPON)/ Ethernet Passive Optical Network (EPON) Technology.
4. The proposed Network will provide data and voice/video connectivity.
5. The Bidder is expected to visit and examine the locations of Government offices as necessary and its surroundings and obtain all information that may be necessary for preparing the Bid at their own interest and cost.
6. The Optical fiber Cable at the State HQ will be of minimum 6 pairs.
7. The estimated OFC length which will be deployed in Imphal East and Imphal West in rings to cover all the areas where Government offices are present is approximately 35 Kms. Bidders are advised to bid Unit prices of Optical Fiber Cable so that in case of any incremental requirements, the expansion may be taken up at the same rate.
8. The Optical fiber Cable at the District HQ will be of minimum 2 pairs.
9. The estimated OFC length at the District is 10 km. Bidders are requested to bid Unit prices of Optical Fiber Cable so that in case of any incremental requirements, the expansion may be taken up at the same rate.
10. Wherever connectivity can be established by using Unshielded Twisted Pair (UTP) within a distance of about 60-80 mts., OFC connectivity may not be deployed.
11. The Operator shall be responsible for end-to-end implementation of the Manipur SWAN horizontal connectivity and shall quote and provide/ supply any item(s) of latest make and model (item (s) should be Dual Stack and should include all necessary hardware and software component to support IPv6).

12. The Vendor responsibility shall include the following tasks:

- a. Round the clock Network Monitoring
- b. Network Performance Management
- c. Network Fault Management
- d. Link Management
- e. Operational Liaison with Bandwidth Service Providers
- f. Quarterly MIS Report generation and submission.
- g. Preventive maintenance, etc.
- h. User Issue log and resolution.

QUALIFYING CRITERIA

1. The bidder should have an annual turnover of **Rs. 1 Crore** and above in any year during the last three financial years of 2012-13, 2013-14, and 2014-15.
2. The bidder should have an authorization from the Original Equipment Manufacturer/ service provider (OEM) for selling and supporting the components/ services offered.
3. The bidder must be a firm registered in India for the last two years as on date of submission of bid.
4. The bidder shall be an Internet Service Provider (ISP) or a franchisee of an ISP engaged in offering internet connection for the last 2 years.
5. The bidder should have atleast 2 year experience in Setting-up, Operation & Maintenance of OFC based WANs with atleast 100 nodes from the State of Manipur.
6. The bidder should have an office in Manipur with a minimum number of manpower as under:
 - a) 6 manpower for OFC splicing (at State Head Quarter)
 - b) 2 System Administrator (at State Head Quarter)
 - c) 4 Network Engineers(at State Head Quarter)
 - d) 2 Network Engineers (at every District Head Quarters)
7. The bidder should submit a declaration stating that they are not debarred/blacklisted by any State Government, Central Government, Central & State Govt. Undertakings/enterprises/Organizations.
8. The Bidder should have valid VAT/ TIN registration certificate. A copy of which should be enclosed.
9. The bidder should submit the audited annual statements of income and expenditure for the last 3 financial years certified by Chartered Accountant.
10. The bidder should be a member of the Indian Broadband Forum / an authorized Franchisee of a company which is a member of the Indian Broadband Forum.

Terms and Conditions

1. The bidder should furnish Tender Fee of Rs. 10,000/- (Rupees Ten Thousand only) along with the bid. Tender Fee should be submitted in the form of Bank Draft/Banker's Cheque of any Scheduled Bank drawn in favour of 'Additional Director (IT), Government of Manipur payable at Imphal only.
2. The bidder should furnish Earnest Money Deposit (EMD) of Rs. 1,00,000/- (Rupees One Lakh only) along with the bid. EMD should be submitted in the form of Bank Guarantee of any Scheduled Bank drawn in favour of 'Additional Director (IT), Government of Manipur payable at Imphal only. EMD submitted in any other form or bid without EMD will be summarily rejected
3. EMD of the successful bidder will be retained as performance security till 90 Days after completion of project and will be forfeited in case of failure to execute the Project. The successful bidder should extent the validity of the Bank Guarantee upto 1 year and 9 months.
4. The Bid will be inclusive of all applicable taxes of On-site Comprehensive Maintenance cost of 1 year of connected offices at the State HQ, District HQs and 3 Block HQ from the date of commissioning. On-Site Comprehensive Maintenance Cost is to be indicated separately for extension after first year if necessary.
5. Response to and resolving of any connectivity issues should be within 4 hours at the State HQ and 1 days for the District HQs/Block HQs. In case of default, penalty will be deducted from the Maintenance Cost @ Rs. 500 per node per day
6. Penalty will be upto a maximum of 10% of the Annual Maintenance Cost.
7. Payment of Comprehensive Maintenance cost will be on basis of Half-Yearly basis.
8. The successful bidder will co-ordinate with the other Agencies of Project such as NIC, Government Departments, Bandwidth service Providers/Network equipment suppliers and DIT, Manipur for commissioning of the Horizontal offices.
9. For those item (s) which are not included in the bill of materials, but required for successful implementation and commissioning of the network as well as its management. The bidder may include the same under Additional Items.
10. The successful bidder will set-up a Network Operations Center (NOC) at DIT, Manipur or any location identified by DIT, Manipur. The successful bidder will provide the following manpower to be attached with DIT, Manipur for maintenance of the NOC and the network:
 - i. 1 (one) Network Administrator
 - ii. 4 (four) Network Engineers who will also take care of the OFC splicing requirement.

11. The successful bidder will also provide 2 Network Engineers at the each District for operation and maintenance of the network at the District Head Quarter. The 2 numbers of Network Engineers will report to the concerned e-District Manager and will be attached to the office of the concerned e-District Manager.
12. The successful bidder will also provide NMS service for monitoring of the entire network and should be able to generate various reports at the request of the State Government.
