NO.20/14/2018-DIH/DP: In pursuance of the decision of the State Cabinet taken in its meeting held on 25-09-2018, the Governor of Manipur is pleased to grant one-time relaxation to the provisions under para 21(b)(i) of the Revised Die-in-Harness Scheme on 07-12-2017 in respect of the following cases:

- (i) Appointment of 658 nos. of pending applications under the 20% quota/norm under the Die-in-Harness Scheme in respect of 16 (sixteen) Departments which were submitted to the Department of Personnel on or before 11-11-2016 (Annexure-A)
- (ii) Appointment of 85 nos. of applicants for the post of Police Constable (Male/Civil) and 21 nos. of applicants for the post of Riflemen under Die-in-Harness Scheme (10% quota) in Home Department for which Special DPCs have already been held on 16-06-2017 to 19-07-2017 and 05-09-2017 to 28-10-2017 respectively.
- 2. The appointment of the above scases under Die-in-Harness Scheme shall be considered strictly as per seniority prepared based on the earlier guidelines/OM existing prior to 07-12-2017 and satisfaction of all other applicable eligibility criteria/conditions as laid down in various OMs for Die-in-Harness Scheme issued by the Department of Personnel, Government of Manipur from time to time.
- 3. Departments at SI.No.1,3,4,7,8,11,14,15 and 16 of **Annexure-A** for whom proposals for appointment under the 20% quota /norm had been returned back to the Administrative Departments concerned for obtaining fresh Administrative Approval are required to re-submit their original proposals to the Department of Personnel with fresh Administrative Approval within 1(one) Month of the issue of this OM for availing the above relaxation failing which the proposals under 20% quota / norm shall not be considered any further.
