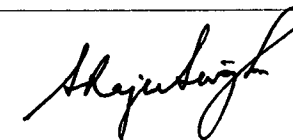

**STATEMENT SHOWING THE EXSITING PROVISION AND PROPOSED AMENDMENT OF THE MANIPUR PLOICE
TELECOMMUNICATION SERVICE RULES, 2015.**

Rule	Existing	Amendment Proposed by AD	Justification
28 (e)	<u>28. Promotion :</u> A member of the Manipur Police Tele-communication Service shall be eligible for promotion to respective higher grades on fulfilment of the conditions as shown below:- (e) Junior Grade : Essential: (1) A member of the service in Schedule – II who completes at least 5 years of regular service and having passed <i>pre-promotional departmental examination</i> conducted by the State Government. N.B. Persons having possessed technical qualification for Direct Recruitment or having passed PGDCA shall be exempted from passing Pre-Promotional Departmental Examination.	<u>28. Promotion :</u> (e) Junior Grade : (1) An Inspector (Telecom) who completes at least 5 years of regular service and having passed any of the following Course shall be eligible for promotion to Junior Grade [Dy. S.P (Telecom)] as given below :- <i>PWCC Level-I (Police Wireless Communication Course- Level- I) of Syllabus Committee Report, 2013 / Inspector (Telecom) who have passed Radio Technician Grade – I Course / Radio Operator Grade-I Course before 2018 (prior to the adoption of the Syllabus Committee Report, 2013) .</i>	1. With the adoption of the New Syllabus for proficiency Course w.e.f. 2018, there is necessity for restructuring the Eligibility Criteria for promotion to the various posts. 2. The eligibility criteria of pre-promotional examination prescribed at the level of Inspector (Telecom) for promotion to MPTS Junior Grade in the MPTS Rules, 2015, shall no longer be relevant and necessary. 3. The Course of the Training are prescribed by the Ministry of Home Affairs.

No. _____ : In exercise of the powers conferred by the proviso to Article 309 of the constitution of India and other powers enabling him in this regard, the Governor of Manipur is pleased to make the following rules further to amend the Manipur Police Tele- Communication Service Rules, 2015 namely :-

1. **Short title and Commencement:**

- (i) These rules may be called the Manipur Police Tele-communication Service (1st Amendment) Rules, 2019.
- (ii) These Rule shall come into force with immediate effect.

2. **Amendment of Rule 28(e) of the Manipur Police Tele-communication Service Rules, 2015:**

Rule 28(e) of the Rules shall be substituted by the following:

Rule 28. Promotion:

Rule 28(e) : For promotion to the Junior Grade post, an Inspector (Telecom) who completes at least 5 years of regular service and having passed any of the following Course shall be eligible for promotion to Junior Grade [Dy.S.P(Telecom)] as given below :-

PWCC Level-I (Police Wireless Communication Course- Level- I) of Syllabus Committee Report, 2013 / Inspector (Telecom) who have passed Radio Technician Grade – I Course / Radio Operator Grade-I Course before 2018 (prior to the adoption of the Syllabus Committee Report, 2013) .
