Further, it is also informed that in case of expiry IREP contract staff, if any, during the period abovementioned or beyond 31/3/2007, the release of their backlog consolidated salary/honoraria to the very next of his/her family kin will be considered, subject to submission of relevant documents such as Death Certificate, Affidavit, Legal heirs Certificate issued by the concerned Sub-Divisional Officer(SDO)/Deputy Commissioner, agreement in the prescribed format duly signed by the party, proper verification of all the documents etc. on or before the stipulated time mentioned above.

3. The terms & conditions for contract engagements laid down in the Finance Dept.'s O.M. No.20/6/97-FD(PIC)(Pt.VI) dtd.19/2/2005 will be applicable.
