O R D E R S

Imphal, the 27th November, 2020

WHEREAS, the undersigned Chairperson, State Executive Committee of the State Disaster Management Authority in exercise of the powers conferred under Section 20(2)(a) of the Disaster Management Act, 2005 issued orders of even No. dated 28/10/2020 detailing the guidelines of the **UNLOCK** to be followed till further orders or till 30/11/2020 in respect of entire state.


2. WHEREAS, Chairman National Executive Committee, in exercise of the powers conferred under section 10(2)(I) of the Disaster Management Act, 2005 issued guidelines for surveillance, containment and caution vide order No.40-3/2020-DM-(I)A dated 25/11/2020.

3. NOW THEREFORE, in exercise of the powers conferred under Section 20(2)(a) of the Disaster Management Act, 2005 the undersigned in his capacity as Chairperson, State Executive Committee of the State Disaster Management Authority hereby orders that the guidelines for surveillance, containment and caution issued by the Chairman National Executive Committee vide order No.40-3/2020-DM-(I)A dated 25/11/2020 is adopted in Manipur with the additional requirements listed below and it will remain in force upto 31/12/2020 or until further orders whichever is earlier.

- (i) There will be **night curfew from 6 pm to 4 am** and District Magistrates will issue orders in this regard. Movement of essential services, goods trucks, and officials on duty shall be exempted.
- (ii) Social and Customary ceremonies should be organised for family members only and in case some other persons are required to attend the ceremony/function the size of the **gathering should be restricted to 20 (twenty) or less persons strictly.**
- (iii) Opening of shops in Thangal and Paona Bazaars except the whole sale shops will be in accordance with the roster as below: [Deputy Commissioners other than Imphal West & Imphal East shall prepare their own schedule for their markets based on local requirement in respect of other districts:

These shops will remain closed on Sunday.

- (iv) Hospitals, Nursing Homes, Clinics, Dispensaries and all Chemists and Pharmacies shall be exempt from Curfew restrictions.
- (v) All Deputy Commissioners and District Superintendents of Police shall enforce The Manipur Epidemic Diseases (Enforcement of Covid-19 Guidelines) Regulation, 2020 strictly.

These orders will be with immediate effect.
