Thoubal, Kakching, Chandel, Noney, Imphal East, Jiribam, Imphal West, Tamenglong, Noney, Senapati, Kangpokpi, Pherzawl and Churachandpur districts for redressal of grievances and disposal of complaints relating to implementation of NREG Act 2005 and Schemes under the Act made by the State. The eligibility criteria viz. essential qualification, experience, sitting allowances etc. are given against the post.
