IN THE COURT OF THE DISTRICT MAGISTRATE, CHURACHANDPUR.
Prohibitory Orders under section 144 of code of criminal procedure 1973)

Churachandpur, the 8th May, 2021.

No. DC(CCP)/Cov-19/Misc/2020: Whereas, the Chairperson of the State Executive committee of the State Disaster Management Authority issued Order No.H-1601/6/2020-HD-HD dated 7th May 2021 for imposition of **CURFEW** from 8th May to 17th May 2021 in view of the increased cases of Covid-19 infections and the District Magistrate have been directed to issue corresponding order accordingly.

2. Whereas, adoption of immediate preventive and precautionary measure to strictly enforce the provisions of "the Manipur Epidemic Diseases (Enforcement of Covid-19 Guidelines) Regulations 2020" is required in the area which is described in the schedule given below.

3. Whereas, to contain the further spread of the Covid-19 in the District, it has become imperative and expedient to issue prohibitory orders imposing **CURFEW** in the entire District from 8th May 2021 to 17th May 2021 as an immediate preventive measure in the interest of public health and well being.


4. Now therefore, **I, Pawan Yadav**, District Magistrate Churachandpur, Manipur In exercise of power conferred under section 2 of section **144 of Cr.P.C 1973, hereby Prohibit any forms of public movement outside their Residence from 8th May 2021 to 17th May 2021** with immediate effect until further Order. As there is emergency and circumstance do not permit serving due notice upon the public, the Order is passed Ex-Parte.

5. These, Order shall however not apply to the categories listed below and shall be allowed free Movements.

- i. All health care facilities including animal healthcare, hospitals, clinics, nursing homes and movements of healthcare workers.
- ii. All pharmacies, including those selling veterinary medicines.
- iii. All persons going for Covid-19 vaccination, Covid testing and medical emergencies.
- iv. All employee and personal staff working in media, Power, Fire Services, PHED, CAF & PD, Health, Home, Relief & DM, Police Department and District Administration.
- v. Only good vehicles, oxygen supply related vehicles, LPG and Oil Tankers, and vehicles of others essential services like power supply, garbage collections, water supply, PDS, medical /covid services, electronic & print media, internet & telecom service providers and Vehicles of personnel of department/organisation permitted to be functional.
- vi. Hotels for lodging will be allowed to remain open with minimum staff. Restaurants to be closed.
- vii. Movements of staff of Imphal airport and passengers.
- viii. Opening of Petrol pump & LPG outlets, while ensuring there is no crowding
- ix. Movements of staff of IOCL.
