There are a total of 53 sanctioned posts of Grade IV employees in Transport Department. As per the RR of LDCs only 10% of the total sanctioned post of 34 LDCs i.e. 3 posts are reserved for promotion of Grade IV which is very less. At present there are a total of 31 Grade-IV employees in Transport Department who are eligible for promotion to LDC. However their promotion could not be processed due to the unavailability of the vacant reserved posts for promotion. Whereas, in case of Checker (Grade IV employees) in Transport Department, the sanctioned posts is 58 and they have reservation of 50% of the total sanctioned post of ASI (Enforcement) for promotion i.e. 16 posts reserved for promotion [50% of 31 total sanctioned post of ASI (Enf)]. Now considering the similar nature of work of ASI (Taxes) and LDC and to provide avenue for promotion of eligible Grade IV-employees in the Department as well as enhancement in revenue collection, 40% reservation of the total sanctioned posts of ASI (Taxes) is proposed.
