No.H-3607/4/2022-HD-HD(Pt.): Whereas, the State Government vide orders No.H-1701/181/2023-HD-HD dated 1st February, 2024 suspended operation of those mobile towers to provide internet services in the stretch of 2 Km radius along adjoining areas between districts of -a) Chandel and Kakching; b) Churachandpur and Bisnupur; c) Churachandpur and Kakching; d) Kangpokpi and Imphal West; e) Kangpokpi and Imphal East; f) Kangpokpi and Thoubal; and g) Tengnoupal and Kakching and had been extended from time to time till date;

- **2**. Whereas, State Government, after reviewing the prevailing law and order situation and its possible co-relation with the general operation of internet suspension in the last fortnight, decided to continue suspension of operation of the Mobile towers as in Para No.1.
- 3. Therefore, the Governor of Manipur is pleased to order suspension of operation of mobile towers to provide internet services in the stretch of 2 Km radius along adjoining areas between districts as listed in Para No. 1 maintaining status quo for another 15 (fifteen) days till 7:45 PM of 02/03/2024 under Rule 2 of Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017 with immediate effect in public interest subject to confirmation within 24 hours by the Competent Authority;
- **4.** These orders has no effect on the earlier orders No.H-3607/4/2022-HD-HD dated 16-02-2024 issued regarding temporary suspension/curbing of internets services, mobile data services, internet/data services through VPN including Broadband (ILL and FTTH) services in the whole revenue jurisdiction of Churachandpur district for 5(five) days i.e., w.e.f., 1:40 A.M. of 16-02-2024 to 01:40A.M. of 21-02-2024.
- 5. All Mobile Service providers are hereby directed to ensure compliance of this order;
- 6. Further, all internet users are requested to refrain from activities which may cause situations which with warrant for suspension of internet services in future;
- 7. This issues with the approval of the Competent Authority and is subject to review at any point of time.
