

> ORDERS Imphal, the 17th March, 2024



No.H-3607/4/2022-HD-HD(Pt.): Whereas, in view of the prevailing law and order situation, State Government vide orders No. H-3607/4/2022-HD-HD(Pt.) dated 2nd March, 2024 suspended operation of those mobile towers to provide internet services in the stretch of 2 Km radius along adjoining areas between districts of - a) Chandel and Kakching; b) Churachandpur and Bisnupur; c) Churachandpur and Kakching; d) Kangpokpi and Imphal West; e) Kangpokpi and Imphal East; f) Kangpokpi and Thoubal; and g) Tengnoupal and Kakching and had been extended from time to time till date:

- Whereas, State Government, after reviewing the prevailing law and order situation and requirement of internet services related to the ensuing General Lok Sabha Elections-2024, decided to revoke the suspension of operation of the Mobile towers as in Para No.1.
- Therefore, the Governor of Manipur is pleased to order revocation of suspension of operation of mobile towers to provide internet services in the stretch of 2 Km radius along adjoining areas between districts as listed in Para No. 1 under Rule 2 of Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017 with immediate effect in public interest.
- All Mobile Service providers are hereby directed to ensure compliance of this order;
- Further, all internet users are requested to refrain from activities which may cause situations which with warrant for suspension of internet services in future;
- 6. This issues with the approval of the Competent Authority and is subject to review at any point of time.
