No. 2/43/2022-Leg/L : The following Act of the Legislature, Manipur which received assent of the Governor of Manipur on August 9, 2022 is hereby published in the Manipur Gazette Extra-Ordinary:

THE MANIPUR LAND REVENUE AND LAND REFORMS (SEVENTH
AMENDMENT) ACT, 2022
(Manipur Act No. 9 of 2022)

*further to amend the Manipur Land Revenue and Land Reforms Act, 1960
(No 33 of 1960)*

Be it enacted by the Legislature of State of Manipur in the Seventy-third Year of the Republic of India as follows:-

1. (1) This Act may be called the Manipur Land Revenue and Land Reforms (Seventh Amendment) Act, 2022. Short title, and commencement.
- (2) It shall come into force from such date as the State Government may, by notification in the Official Gazette, appoint.
2. In section 4 of the Manipur Land Revenue and Land Reforms Act, 1960 (hereinafter referred to as the Principal Act), for clauses (a) to (n), the following clauses shall be substituted, namely, - Amendment of section 4.
 - “(a) Revenue Secretary/ Commissioner;
 - (b) Deputy Commissioner;
 - (c) Additional Deputy Commissioner;
 - (d) Director of Settlement and Land Records;
 - (e) Sub-Divisional Officers;

- (f) Assistant Commissioner;
- (g) Survey and Settlement Officers;
- (h) Assistant Survey and Settlement Officers;
- (i) Settlement Supervisor;
- (j) Sub-Deputy Collectors;
- (k) Revenue Inspectors;
- (l) Supervisor Kanungos;
- (m) Jilladars;
- (n) Mandols;
- (o) Such other village officers and servants as may be appointed by order made under this Act."

Amendment of section 6. 3. In section 6 of the Principal Act, for the words and characters "in terms (c), (f) and (g) of section 4", the words and characters "in items (d), (g), (h) and (i) of section 4" shall be substituted.

Insertion of section 14A. 4. After section 14 of the Principal Act, the following section 14A shall be inserted, namely, -

"14A. Power of the Government to lease out land. The State Government shall have the power to lease out any land belonging to the Government for the purpose of an industry or for any purpose of public utility on such conditions as may be prescribed."

Amendment of section 51-D. 5. In section 51-D of the Principal Act, for the word "unused", the word "used" shall be substituted.

Amendment of section 51-K. 6. In section 51-K of the Principal Act,-
(i) for the words "Sub-Deputy Collector", the words "Deputy Commissioner" shall be substituted.
(ii) in clause (c), for the words "on which all the new holding of which they originally form a part", the words "on which each of the new holdings or in the holding of which they originally form a part" shall be substituted.

Amendment of section 106. 7. In sub-section (2) of section 106 of the Principal Act, the words and characters "Assam Co-operative Societies Act, 1949", the words and characters "Manipur Societies Registration Act, 1989" shall be substituted.

Amendment of section 155. 8. In section 155 of the Principal Act, for the words "one hundred rupees", the words "fifty thousand rupees" shall be substituted.

Amendment of section 158. 9. In section 158 of the Principal Act, the following proviso shall be inserted, namely,-
158. "Provided that this section will be applicable only in areas within the jurisdiction of the District Council."
