NOTIFICATION

Imphal, the 25th August, 1987
No. 1/35/00-RR/DP : In supersession of all previous orders in this regard and in exercise of the powers conferred by the provision to Article 309 of the Constitution of India, the Governor of Manipur hereby makes the following rules regulating the method of recruitment to the post of Accountant in the Departments/Offices under the Government of Manipur as shown in the MPSC Form-0 namely:-

1. **SHORT TITLE** :- These rules may be called the Departments/Offices of the Government of Manipur (Accountant) Recruitment Rules, 1987.

2. **APPLICATION** :- These rules shall apply to the post specified in column 1 of the MPSC Form-0 hereto annexed.

3. **CLASSIFICATION, SCALE OF PAY, METHOD OF RECRUITMENT ETC.** :- Classification of the said post, scale of pay, method of recruitment and other matters connected therewith shall be as specified in the column 3 to 13 of the said MPSC Form - 0.

4. **DISQUALIFICATION** :- (a) No person, who has more than one wife living or who having a spouse living, marriage in any case in which such marriage is void by reason of its taking place during the lifetime of such spouse, shall be eligible for appointment to the aforesaid post, and

(b) no woman, whose marriage is void by reason of husband having a wife living at the time of such marriage or who has married a person who has a wife living at the time of such marriage, shall be eligible for appointment to the said post.

Provided that the Governor of Manipur may, if satisfied that there are special grounds for so ordering, exempt any person from the operation of this rule.

5. **Power to relax** :- Where the Governor is of opinion that it is necessary or expedient so to do, he may order, for reasons to be recorded in writing, and in consultation with the Department of Personnel & Administrative Reforms (Personnel Division), Government of Manipur, for relaxation of any of the provisions of these rules with respect to any class or category of persons or posts.

6. These rules shall come into force with effect from the date of publication in the Manipur Gazette.
