In supersession of all previous rules issued in this regard and in exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Manipur hereby makes the following rules regulating the method of regruitment to the post of Lower Division Clerk(LDC) in the Offices/ Departments under the Government of Manipur other than Manipur Secretariat/ Assembly Secretariat Governor's Secretariat/MPSC/ Treasuries & Accounts Department/ Judicial Department/ Police Department, Manipur as shown in the M.P.S.C. Form-8, namely :-

- These rules may be called the Offices/ Departments under the Government of Manipur other than Manipur Secretariat/ Assembly Secretariat/ Governor's Secretariat/MPSC/ Treasuries & Accounts Department/ Judicial Department/ Police Department, Manipur. [Lower Division Clerk(LDC)] Recruitment
- 2. Application: These rules shall apply to the post specified in column 1 of the M.P.S.C. Form-8 hereto
- 3. Classification. Scale of pay, method of recruitment etc. :- Classification of the said post, scale of pay, method of recruitment and other matters connected therewith shall be as specified in the columns 3 to 13 of
- Disqualifications :-
- (a) No person, who has more than one wife living or who having a spouse living, marries in any case in which such marriage is void by reason of its taking place during the life time of such spouse, shall be eligible for appointment to the aforesaid post, and
- (b) No woman, whose marriage is void by reason of the husband having a wife living at the time of such marriage or who has married a person who has a wife living at the time of such marriage, shall be eligible

Provided that the Governor of Manipur may, it satisfied that there are special grounds for so ordering, exempt any person from the operation of this rule.

- 5. "Power to relax Where the Governor is of opinion that it is necessary or expedient so to do, he may order, for reasons to be recorded in writing and in consultation with the Department of Personnel & Administrative Reforms(Personnel Division), for relaxation of any of the provisions of these rules with respect to any class or category of persons or posts."
- 6. These rules shall come into force with effect from the date of publication in the Manipur Gazette.
