No. 1/36/93-RR/DP.-In supersession of all previous rules issued in this regard and in exercise of powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Manipur reby makes the following rules regulating the method of recruitment to the post of Additional Director orti) in the Department of Horticulture & Soil Conservation, Manipur as shown in the M.P.S.C. rm-8, namely:-

Short title:-These rules may be called the Department of Horticulture & Soil Consevation, inipur [Additional Director (Horti)] Recruitment Rules, 2011.

Application: - These rules shall apply to the post specified in column 1 of the M.P.S.C. Form-8 reto annexed.

Classification, scale of pay, method of recruitment etc: -Classification of the said post, scale of , method of recruitment and other matters connected therewith shall be as specified in the columns o 13 of the said MPSC Form-8.

Disqualifications:-

- (a) No person, who has more than one wife living or who having a spouse living, marries in rease in which such marriage is void by reason of its taking place during the life time of such ouse, shall be eligible for appointment to the aforesaid post, and
- (b) No woman, whose marriage is void by reason of the husband having a wife living at the time such marriage or who has married a person who has a wife living at the time of such marriage, shall eligible for appointment to the said post.

Provided that the Governor of Manipur may, if satisfied that there are special grounds for so lering, exempt any person from the operation of this rule.

"Power to relax – Where the Governor is of opinion that it is necessary or expedient so to do, he ay order, for reasons to be recorded in writing and in consultation with the Manipur Public Service Commission, relaxation of any of the provisions of these rules with respect to any class or category of persons or osts."

These rules shall come into force with effect from the date of publication in the Manipur azette.
