NOTIFICATION

No. 1/77/18-RR/DP.—In supersession of all previous rules issued in this regard and in exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Manipur hereby makes the following rules regulating the method of recruitment to the post of Joint Director (Soil Conservation/Sr. Horticulturist) and other posts with an identical scale of pay and similar duties in the Horticulture & Soil Conservation Department, Manipur as shown in the MPSC Form-8, namely:—

1. Short title & commencement.—(1) These rules may be called the Horticulture and Soil Conservation Department, Manipur, Joint Director/Sr. Horticulturist Recruitment Rules, 2004.

(2) They shall come into force with effect from the date of publication in the Manipur Gazette.

2. Application.—These rules shall apply to the post specified in column 1 of the MPSC Form-8 annexed hereto.

3. Classification, scale of pay, method of recruitment etc.—Classification of the said post, scale of pay, method of recruitment and other matters connected therewith shall be specified in columns 3 to 13 of the said MPSC Form-8.

4. Disqualifications—No person

- (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the aforesaid post,
