## NOTIFICATION Imphal, the 14th January, 1983

No. 1/87/73-RR/DP: In supersession of all provious reles in this regard and in exercise of the povers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Menipur hereby makes the following rules regulating the method of recruitment to the posts of Supervisor & Superintendent (Technical), 1.T.I. in the Labour Department, Manipur, as shown in the MMSC Form-B, namely :-

- 1. Short title :- These rules may be called the Labour Bepartment, Manipur /Supervisor & Superintendent (Technical), I.T. I.D. Recruitment Rules, 1983.
- 2. Application: These rules shall apply to the post specified in column 7 of the MPSC Form-8 hereto annoxed.
- 3. Classification, scale of pay, method of recruitment etc.:Classification of the said post, scale of pay, method of recruitment and other matters connected therewith shall be as specified in golumna 3 tu 13 of the MPSC Forme8,
- 4. Disqualification : (a) No person, who has more than one wife living or who having a spouse living, marries in any also in which such marriage is void by reason of its taking place during the life-time of such spouse, shall be eligible for appointment to the aforesaid post, and.

(b) no woman, whose marriage is void by reason of husband having a wife living at the time of such marriage or who has married a person who has a wife living at the time of such marriage, shall be cligible for appointment to the said post;

Provided that the Governor of Manipur may, if satisfied that there are special grounds for so ordering, exempt any person. from the operation of this rule.

"Power to relax - Where the law rnor is of opinion that it is nesessary or expedient so to do, he may order, for reasons to be recorded in writing, and in consultation with the Department of Personnel & Administrative Reforms (Personne: Division), Government of Manipur, for relaxation of any of the provisions of these rules with respect to any class or category of persons or posts",

6. These rules shall come into force with effect from the date of publication in the Manipur Gamtte.
